

Terms and Conditions Governing the OCBC StarHub Customer Lucky Draws

The following terms and conditions shall apply to eight (8) OCBC StarHub Lucky Draws to be held for Eligible Customers (the “Promotion”).

1. Eligibility

- 1.1 The Promotion period starts from 10 May 2018 and ends on 4 July 2018, both dates inclusive (“Promotion Period”).
- 1.2 “Eligible Customer” means any customer, whom, during the Promotion Period, holds at least one (1) OCBC Card, or OCBC Deposit Account, or OCBC Loan, or Insurance product purchased through OCBC, or Investment product purchased through OCBC as the main holder, AND at least one (1) active (not suspended) StarHub Postpaid Mobile, StarHub Prepaid Mobile, StarHub Broadband or StarHub TV subscription as the subscriber on record.

2. Promotion Mechanics

- 2.1 There will be eight (8) Lucky Draws that the Eligible Customer can participate in, with the registration periods and prizes set out below:

- 2.2 To participate in any Lucky Draw, the Eligible Customer shall, within the Registration Period:

- 2.2.1 Register for the Lucky Draw at www.innovatingtogether.sg;

- 2.2.2 Submit his or her name, NRIC and contact details on an electronic registration form provided;
and
- 2.2.3 Give his/her consent to OCBC Bank and StarHub (“OCBC-StarHub Consent”) to share his/her personal data with third parties from the date of registration and for at least 12 months after the expiration of the Promotion Period.
- 2.3 Each Eligible Customer will have one chance for each Lucky Draw. If an Eligible Customer wishes to participate in all eight (8) Lucky Draws, he/she will need to submit his/her registration eight (8) times, once during each relevant registration period.
- 2.4 The eligibility of each Eligible Customer for each Lucky Draw is determined at the sole discretion of OCBC and StarHub, whose decision shall be final.
- 2.5 The chance allocated to each Eligible Customer is not transferable.
- 2.6 The Prize Winners for each Lucky Draw will be drawn on the dates set out below:

- 2.7 The Prize Winners will be randomly selected under the supervision of independent auditors. OCBC and StarHub reserve the right to draw reserve winners, to replace the winner if he/she is subsequently found to be ineligible.
- 2.8 The Prize Winners will be notified within seven (7) working days from the draw date. A prize redemption letter will be sent to his/her mailing address in OCBC’s records.
- 2.9 OCBC and StarHub will publish a list of all prize winners for all of the Lucky Draws at www.innovatingtogether.sg, within seven (7) days from the dates of the draws on 29 June 2018 and 23 July 2018 respectively. By participating in the Promotion, all participants agree to the disclosure of their personal information in the manner set out in these terms and conditions.
- 2.10 The Prize Winner is bound by these terms and conditions and any other conditions that OCBC and StarHub may impose upon redemption of the prize (including requiring the prize winner to provide identification and to sign a letter to acknowledge his/her redemption of the prize).
- 2.11 The Prize Winner collects the prize at his/her own cost and risk.
- 2.12 Should the Prize Winner not redeem the prize by the date set out in the prize redemption letter, the prize will be automatically forfeited without further notice. OCBC and StarHub will not compensate the Prize Winner (including reserve Prize Winners) for the prize in any other way.

- 2.13 OCBC and StarHub reserve the right to charge the value of the prize to the Prize Winner should the Prize Winner withdraw his/her OCBC-StarHub Consent from either OCBC Bank or StarHub within 12 months after the expiration of the Promotion Period.
- 2.14 Prizes are not transferable or exchangeable for cash, credit or kind.
- 2.15 OCBC and StarHub will not be responsible for the quality, merchantability, specifications, performance or any other aspect of the prizes.
- 2.16 OCBC and StarHub will not at any time be held responsible, for any defect or malfunction of the prize, or any damage, harm, injury or loss suffered or caused by or in connection with the use of the prize by anyone.
- 2.17 OCBC and StarHub reserve the right to change or withdraw the prizes with any other items at their discretion, without any notice and without giving any reason.
- 2.18 OCBC and StarHub accept no responsibility for any tax implications that may arise from the prize or from the receipt or use of the prize.

3. General

- 3.1 OCBC and StarHub reserve the right to terminate the Promotion or vary, add or delete any of these terms and conditions without notice, including but not limited to, determining the eligibility of any Eligible Customer, the methods of identifying the prize winner, the prizes, the date of the Promotion and the date of the draws.
- 3.2 OCBC and StarHub's decision on all matters relating to the Promotion will be final and binding on all participants. In the event of any inconsistency between these terms and conditions and any marketing material relating to the Promotion, these terms and conditions shall prevail.
- 3.3 These terms and conditions shall be governed by laws of Singapore and the participants in the Promotion irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
